BACKGROUND

The Environmental Protection Agency (EPA) through the United Nations Development Program (UNDP) Energy & Environment Program/Country Program Support intents to support the Government of Liberia through the Environmental Protection Agency to conduct mapping of degraded areas, raise awareness and establish tree nursery in Voinjama, Lofa County

The Environmental Protection Agency (EPA) is the principal authority in Liberia responsible for the management of the environment; coordinate, monitor, supervise and consult with relevant stakeholders on all activities in the protection of the environment and sustainable use of natural resources.

Pursuant to this, the EPA with support from the United National Development Program (UNDP) intends to hire a National Consultant to conduct mapping of degraded areas, raise awareness and establish tree nursery in Voinjama, Lofa County. Considering the above, the UNDP through the Energy & Environment Unit of the EPA requests the services of a National Consultant to work in collaboration with the EPA in achieving this objective.

With the plethora of challenges, the Energy and Environment (E&E) programme of the UNDP seeks to support the Government's efforts in achieving diversified and inclusive economic growth through investments in sustainable and environmentally friendly agriculture, food security, job creation and improved resilience to climate change and natural disasters. UNDP works to empower the population and build a resilient nation. It supports the government to develop and implement interventions aimed at improving the lives of the people, including women, youth and People living with Disability (PWD).

Through its Energy and Environment (E&E) Programme, UNDP supports the government through its relevant Ministries, Agencies and Commissions (MACs) to address environmental issues and mitigate their impacts to support the collective growth and development of the country.

Contract and Reporting Requirements

The Consultant will be hired against a performance-based contract for two (2) months (May 1 – July 2, 2024. He/she will report to Coordinator of the EPA-UNDP Energy & Environment Unit. The Consultant shall submit reports summarized below, for the respective period(s). All documents/reports should be issued in English, submitted in both hard and electronic copies.

- Monthly Progress Reports: The Consultant shall prepare weekly concise reports with the relevant information on progress, highlighting achievements, emerging issues that need to be clarified with the client and recommendations.
- Final Report: Before the end of the assignment: The Consultant shall submit a final report detailing all the activities undertaken. The report should outline achievements, issues and lessons learnt.

Scope of Work and Tasks

The Consultant will have the following responsibilities:

- Conduct study and review of reports/findings of degraded land across Liberia but with specificity on Voinjama, Lofa County.
- Document causes and impacts on the environment and affected communities.
- Map degraded areas in Voinjama, Lofa County.
- Conduct awareness within affected areas in Voinjama, Lofa County on the environmental impact of land degradation and the importance of forest/land reclamation
- Conduct training/awareness within affected communities in Voinjama, Lofa County in tree nursery establishment.
- Ensure that tree nursery pilot initiative in established within affected communities of Voinjama, Lofa County.
- Carryout all necessary stakeholders' consultations, recommendations, inputs, amendments, and edits.
- Conduct stakeholders' inception and validation meetings when require.
- Liaise with the Forestry Development Authority local office in the planning and implementation of the project activities (mapping, trees selection, nursery establishment, trees planting, etc.), ensuring alien invasive species are not selected.

Job Responsibilities:

- 1) Review and recommend the appropriate remedial approaches.
- 2) Advance ideas on how all remaining protected areas/lands can be used wisely and integrated into land use planning.
- 3) Make suggestions on how human needs while sustaining biodiversity can be harmonised and met
- 4) Suggest how to protect historical sites that are being degraded by unregulated human activities.
- 5) Developed comprehensive plan for degraded land use/management, ensuring it is aligned with the country national policy
- 6) Submit final report in both soft and hard copies.

Key Expected Results

- Comprehensive degraded areas mapping in Voinjama, Lofa County is conducted.
- Awareness is raised on the environmental and human impacts cause by land degradation.
- Awareness is raised on tree nursery establishment.
- Comprehensive plan for degraded land use/management inclusive of essential services they provide, ensuring it is aligned with the country national policy is developed.
- One pilot trees nursery established with not less than 2000 seedlings including fruit trees.
